A review of records of the Oklahoma City Division of the Federal Bureau of Investigation on June 2, 1977, revealed no instances of improper or unlawful conduct by the Federal Bureau of Investigation in connection with the Founding Church of Scientology of Washington, Inc. or L. Ron Hubbard.

Specifically, there have been no informants utilized, no pretext telephone calls or visits to Scientology locations, no warrantless electronic surveillances, no mail covers, no mail openings or other unlawful conduct. Additionally, there has been no dissemination of information to outside persons or mencies.



The Norfolk Division of the Federal Bureau of Investigation (FBI) conducted no investigation of the Founding Church of Scientology of Washington, D. C., Inc. or of L. Ron Hubbard; however, in 1968 information concerning "Scientology" was voluntarily furnished the Norfolk FBI Office. This information was placed in a memorandum under the title "Scientology:

(A copy of thes memorandum is attached.)

In March, 1968, the following information was orally furnished

"The Bureau (FBI) has not investigated Scientology. It was founded by Lafayette Ron Hubbard who created it for the purpose of furthering his theory of "Scientology," an alleged science which installs self-confidence and assists individuals in removing mental problems.

"The April 24, 1951 issue of the 'Washington Times Herald' carried an article indicating that

Hubbard's wife is suing him for divorce, had claimed that he was 'hopelessly insane'. According to this article, 'competent medical advisors recommended that Hubbard be committed to a private sanatorium for psychiatric observation and treatment of a mental ailment known as paranoid schizophrenia'.

"In January, 1963, the Food and Drug Administration directed a raid against the Academy of Scientology in Washington, D.C., in which machines used by the Academy in the practice of Scientology were seized. It was alleged that these machines, known as 'Hubbard Electrometers', were falsely advertised as being effective in ' treating various types of illnesses."

Norfolk FBI obtained no information concerning the Founding Church of Scientology of Washington, D.C. or L. Ron Hubbard, utilizing techniques alleged in the Plaintiff's Complaint.
