The Cleveland Office of the FBI has never disseminated any information it might have concerning the Founding Church of Scientology or L. RON HUBBARD.

The files of the Cleveland Office of the FBI reveal no disclosures of any kind have been made regarding the Founding Church of Scientology or L. RON HUBBARD under the Freedom of Information Act.
