WFO 100-0-16546 - Indicates District Number 4 OSI made an inquiry regarding the Church of Scientology in January, 1959. They were furnished information regarding the Church which had been furnished to the WFO by Byron Inc. (Film Company), Washington, D.C. (WDC) in September, 1958. Byron Inc. reported they were synchronizing film with sound for the Church and the material appeared communisticly inclined.

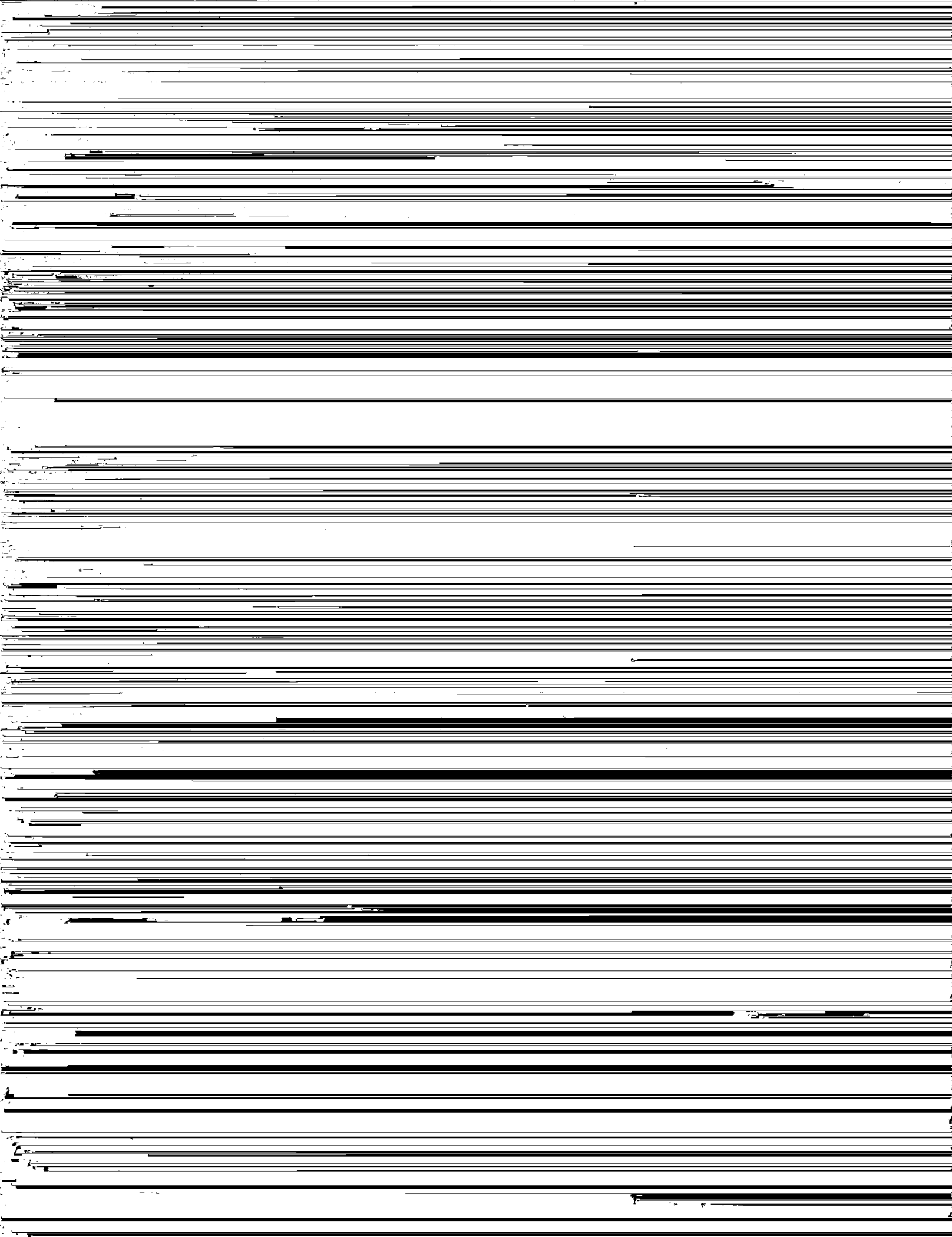
This organization is apparently a forerunner of or
