SCIENTOLOGISTS.

WASHINGTON (AP) - NEWLY RELEASED DOCUMENTS SAY CHURCH OF SCIENTOLOGY LEADERS STOLE INTERNAL REVENUE SERVICE RECORDS ON SINGER FRANK SINATRA AND LOS ANGELES MAYOR TON BRADLEY.

CHURCH MEMOS IN THE DOCUMENTS REVEAL INFORMATION WAS STOLEN ON BRADLEY, SINATRA AND OTHER WELL KNOWN FIGURES **TO SHOW IRS COLLECTION OF NON-TAX RELATED DATA ON FAMOUS PEOPLE.**

THE CHURCH CLAIMS THE IRS AND OTHER AGENCIES HAVE CARRIED ON A VENDETTA AGAINST IT OVER THE YEARS.

THE ACTUAL RECORDS ON SINATRA AND BRADLEY WERE NOT AMONG THE SIX CARTONS OF DOCUMENTS RELEASED THURSDAY BY U.S. DISTRICT JUDGE CHARLES R. RICHEY. THE DOCUMENTS WERE SEIZED IN 1977 DURING FBI RAIDS OF THE CHURCH'S LOS ANGELES OFFICES.

LAST FRIDAY, RICHEY CONVICTED EIGHT CHURCH LEADERS OF CONSPIRING TO STEAL GOVERNMENT DOCUMENTS ABOUT THE CHURCH: A NINTH MEMBER WAS CONVICTED OF A MISDEMEANOR THEFT COUNT.

JUST BEFORE THE VERDICT, RICHEY RELEASED DOCUMENTS USEDIMENTE GOVERNMENT IN THE CRIMINAL CASE. THURSDAY, HE BEGAN MAKING PUBLIC REMAINING DOCUMENTS SEIZED IN THE RAID.

KENNEDY'S PRESS SECRETARY, TOM SOUTHWICK, SAID HE COULD NOT CONFIRM THE MEETING NOR THE VIEWS ATTRIBUTED TO THE SENATOR.

WASHINGTON (AP) -- THE SUPREME COURT TODAY REBUFFED THE CHURCH OF SCIENTOLOGY'S ATTEMPT TO RECOVER DOCUMENTS SEIZED BY THE FBI IN A 1977 RAID ON CHURCH OFFICES IN LOS ANGELES.

WITHOUT COMMENT, THE JUSTICES LEFT INTACT A RULING THAT THE CHURCH HAS NO LEGAL RIGHT TO RECOVER THE DOCUMENTS WHILE CRIMINAL PROCEEDINGS ARE PENDING AGRINST SOME CHURCH MEMBERS.

ABOUT 150 FBI AGENTS, ARMED WITH SEARCH WARRANTS AND CROW BARS, SEIZED THOUSANDS OF DOCUMENTS FROM THE CHURCH'S LOS ANGELES OFFICES EARLY IN THE MORNING OF JULY 8, 1977.

R SIMULTANEOUS FBI RAID AND SEARCH WAS CONDUCTED AT THE FOUNDING

CHURCH OF SCIENTOLOGY OFFICE IN MASHINGTON, B.C.

DAYS LATER, THE CHURCH OF SCIENTOLOGY RIKED A FEDERAL JUDGE TO FORCE THE FBI TO RETURN THE DOCUMENTS SEIZED IN LOS ANGELES. THE REQUEST SAID THE SEIZURES WERE BASED ON UNCONSTITUTIONAL SEARCH MARRANTS.

THE REQUEST ULTIMATELY HAS REJECTED, AND THE CHURCH APPEALED TO THE 9TH U.S. CIRCUIT COURT OF APPEALS. WHILE THAT APPEAL WAS PENDING, A FEDERAL GRAND JURY HERE INDICTED 11 CHURCH EMPLOYEES AND OFFICIALS ON CHARGES OF CONSPIRACY, DESTRUCTION OF JUSTICE AND THEFT OF 62 117658-A-GOVERNMENT PROPERTY.

MANY OF THE DOCUMENTS SEIZED IN THE LEGIPLES FOR THE WERE PRESENTED TO THE GRAND JURY. PROSECUTOR SEALLY INEX HOULD PROVE THAT THE SCIENTOLOGISTS PLANTED SPIES IN THE JUSTICE DEPARTMENT AND INTERNAL REVENUE SERVICE AND STOLE FEDERAL DOCUMENTS.

THE CIRCUIT COURT RULED THAT THE TRIAL JUDGE'S ORDER BLOCKING THE DOCUMENTS' RETURN COULD NOT BE APPEALED WHILE THE CRIMINAL PROCEEDINGS WERE PENDING.

NINE OF THE 11 SCIENTOLOGIST DEFENDANTS WERE CONVICTED ON VARIOUS CHARGES LAST OCT. 26/AFTER A TRIAL IN WASHINGTON. THE TWO REMAINING DEFENSANTS RECENTLY MERE ORDERED EXTRADITED FROM BRITAIN TO STAND
