

A REPORT ON INTERPOL

Interpol, the code name for the secret International Criminal Police Organization, is controlled by no government; they are entirely autonomous. They have the reputation of being a highly effective crime stopping unit, with agents world wide. In reality Interpol is an enormous storehouse of dossiers on over 1,500,000 people. The only legitimate use they have is to give data on suspected criminals to the police departments of the 122 member countries. Members include communist bloc countries Yugoslavia and Rumania. This gives Russia an indirect link to the FBI's huge National Crime Information Center, since Interpol has access to this. This gives communist countries access to the files on a countless number of Americans. The highly communist, new government of Vietnam is also a member. Terrorist nations such as Syria, Cuba, and Chile are also members, giving terrorists direct links!

Interpol was formed in 1924; in 1938 it's files and offices were moved to Berlin and officially controlled by Nazi Germany. In 1942 the "final solution to the Jewish problem" was worked out in Interpol headquarters in a meeting called by it's president Reinhard Heydrich. That infamous solution was the execution of some 6,000,000 Jews. Heydrich was succeeded as president by Dr. Ernst Kaltenbrunner, a Gestapo chief who was hanged at Nuremberg for war crimes. At the end of the war Interpol was officially disbanded with the arrest of most of it's top officials. It was recreated in 1946 by Florent Louwage, a Nazi collaborator working for the Belgian Internal Police during the war. He was backed financially by Nazi funds he withdrew from a special account.

Since it's recreation Interpol has openly refused to help apprehend known nazi war criminals! Not suprising when you know it's president from 1968-1971, Paul Dickopf, was an SS officer (#337259) until he fled Germany when he apparently sensed the tide of victory turning.

There is a clause in Interpol's constitution stating: "it is strictly forbidden for the organization to undertake any intervention or activities of a political, military, religious or racial character." This is the clause they use to justify their refusal to help apprehend nazi war criminals, and to explain their refusal to fight terrorism. Other "crimes" don't seem to fall into this area, although obviously being political, racial, military or religious. Interpol has extensive files on jews and catholics and they helped Czechoslovakia apprehend political refugees in 1950. In 1969 members of Bermuda's Parliament charged Interpol, FBI, and CIA representatives were at the Bermuda airport, pointing out delegates that they did not want to attend the 4-day International Black Power conference held there.

Terrorism in the United States is a very real problem. According to FBI director Clarence Kelley, the FBI has received information of threats to "disrupt" the Bicentennial celebrations. Also Kelley states, "I'm not saying that our nation is in imminent danger of being devastated by terrorists. But I do consider terrorism a very real and growing problem."

While according to Kelley the FBI is going to use "unusual methods" in an effort to control terrorism this year, Interpol, which is partially

funded by U.S. taxpayers, absolutely refuses to give information concerning terrorists. This refusal to do anything at all to fight terrorism in effect acts to support terrorism. Interpol also supports terrorism by giving information to terrorist nations, and undermines democracy by giving information to communists.

In conclusion, while congressional investigations into Interpol taking place need considerable time to create legislation opposing U.S. membership in Interpol, effective action can be taken right now in police departments by refusing to send information to Interpol. Your support is needed to keep Colorado and the U.S. safe from terrorism.

The only way that can be done is by cutting off Interpol in this area.

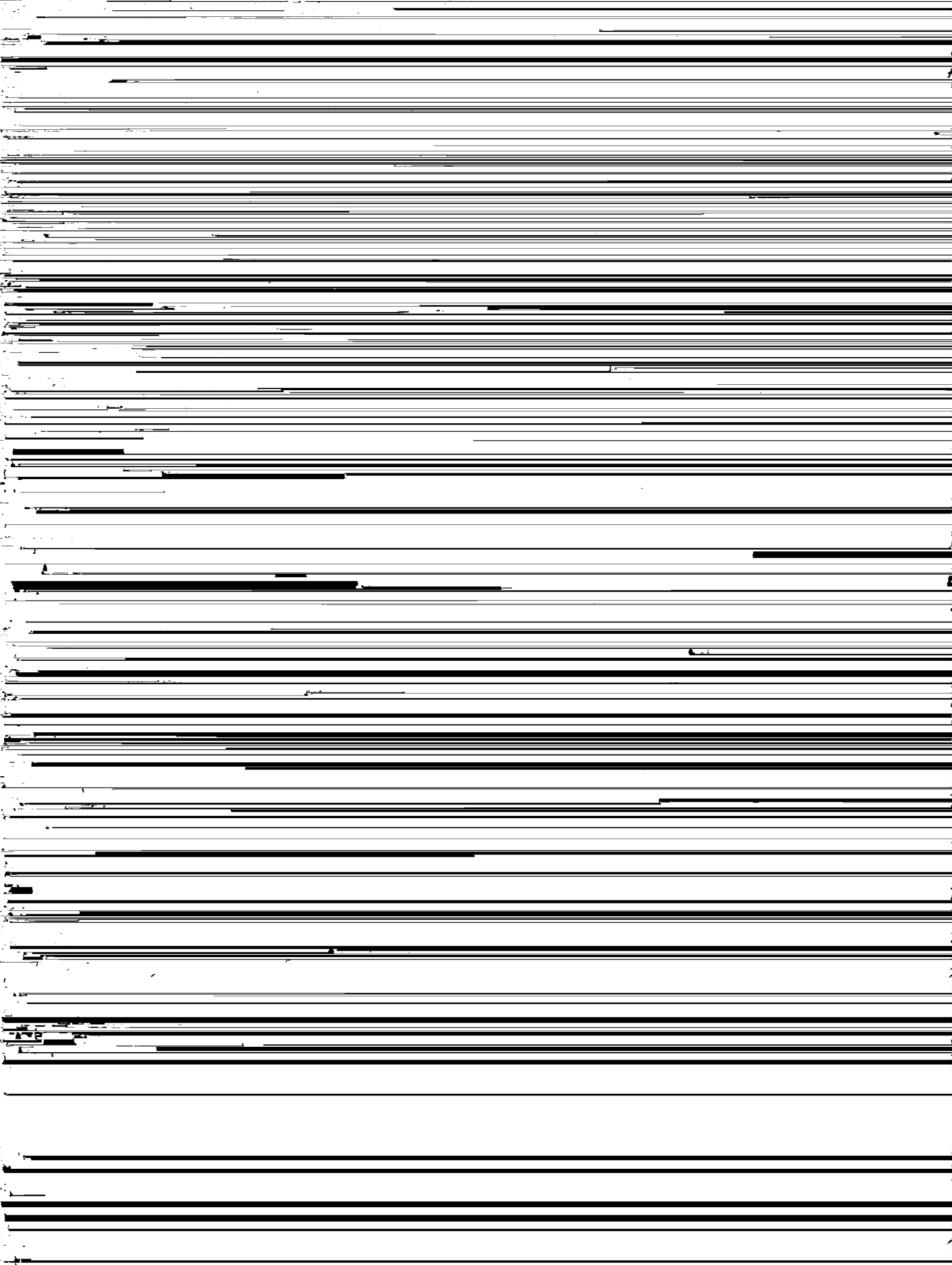

advised on April 30, 1973 that 811 South Beacon Street, Los Angeles, is occupied by the Church of Scientology, and there are several other branches in the Los Angeles area. He advised that he believed that "Excalibur" was a boat belonging to the Church, which he has seen mentioned on signs in the office and described as going on cruises. [REDACTED] further advised that Scientology is expanding its operations into Canada and Mexico, and sending out literature asking for individuals to come to Los Angeles for courses at the Church. He further advised that the Los Angeles editorial offices of the Church of Scientology were around the corner at 2015 West Ninth Street, Los Angeles. (b)(7)(C) (b)(7)(D)

Records of the U. S. Coast Guard, Long Beach, California, indicated on May 1, 1973 that the Church of Scientology currently has four boats registered - "Neptune", "Ares", "Checkmate" and "Makaira". There is no record of a current registration for T.S.M.Y. Excalibur.

A Special Agent of the Federal Bureau of Investigation (FBI) observed on April 30, 1973 that the address 2005 West Ninth Street is occupied by a building with the name of Church of Scientology. A newspaper rack in front contained copies of the March-May 1973 issue of "Freedom", published by the Church of Scientology. A copy was obtained and is attached.

The files of the Los Angeles Office of the FBI contain no record of T.S.M.Y. Excalibur. Los Angeles files contain the following information concerning Scientology:

A publication entitled "Reality" dated May 1960, is self-described as the official publication of Dianetics and Scientology in California and the western United States.
