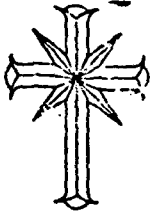

I was informed by Mr. Kendrick Moxon of the Church of Scientology that you are the FBI agent in charge of the investigation of an ex-member of the Founding Church of Scientology, [redacted]. Therefore I believe that you will be interested in another occurrence surrounding this investigation by the FBI.

It was reported to our national offices in Los Angeles that on October 15, 1976 two FBI agents, one by the name of [redacted] and the other unknown, made a professional visit to the Champagne-Urbana Mission of the Church of Scientology in Champagne, Illinois, and spoke to the Executive Director, Dan McNichols. The stated reason for the visit was to inquire about the whereabouts and collect additional information about [redacted]. According to our reports Mr. McNichols answered the questions asked by the agents and the agents left the premises.

The alarming factor of the occurrence, is the fact that this same mission was broken into several days later on the night of the 20-21 of October. Several items were found missing from the mission.

Due to the recent press accounts concerning FBI break-ins, it would ease our minds considerably to have you look into this matter and verify the extent of the FBI involvement in this break-in. Hopefully you will discover that this was not an FBI ploy as I believe that our Church has been most accomadating to the Bureau in its investigation.
