THE ORDER WAS SIGNED BY JUDGE BRYANT AND AGREED TO BY THE PARTIES PERMITTING THE UNITED STATES (US) GOVERNMENT TO USE ALL DOCUMENTS SEIZED IN A CRIMINAL INVESTIGATION BUT PROHIBITING THE GOVERNMENT FROM DISSEMINATING NON-GOVERNMENT ORIGINATED DOCUMENTS SEIZED FOR A PERIOD OF TEN DAYS.
