SIX QUESTIONS WHICH DEALT WITH THE GENERAL SUBJECT OF SUPPOSED HARASSMENT OF THE CHURCH OF SCIENTOLOGY BY THE JUSTICE DEPARTMENT AND THE FBI. DUBON ALSO LEFT A 113 PAGE BOOKLET ENTITLED, "THE AMERICAN INQUISITION" WHICH PRESENTED AN INEPT ARGUMENT ALLEGING GOVERNMENTAL RELIGIOUS PERSECUTION AND ABUSE OF POWER. DUBRON WAS ADVISED AT THE END OF THIS CONTACT THAT NO COMMENT WOULD BE FORTHCOMING CONCERNING THE QUESTIONS RAISED AS THE MATTER WAS CURRENTLY IN LITIGATION AND ANY RESPONSE BY THE GOVERNMENT WOULD BE INAPPROPRIATE.
