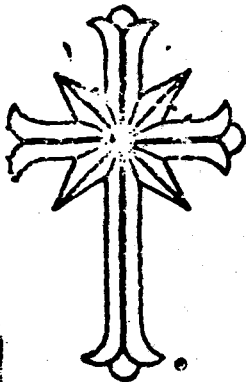

Dear Sirs:

I address you on behalf of the thousands of members of the Church of Scientology in the greater metropolitan area who share with me a concern for the preservation of their constitutional rights under the 1st and 4th Amendments.

The Church and its members seek a more orderly society free from lawlessness and crime and are noted for their non-violent behavior and strong interest in enhancing our culture.

It must be understood, however, that we will not continue to tolerate deprivations of the rights of our fellows through any of the actions of Justice Department (figures) who act illegally and outside the protections set forth by our Founding Fathers.

Today we are demanding answers and explanations from you on issues relevant to our concerns.

Irrespective of any legal arguments still before the courts we demand to know:

- 1) Why are Assistant U.S. Attorneys, Justice Department and FBI behaving diametrically opposite to Carter administration human rights guidelines in their dealing with the Church of Scientology? (Re: massive raids that smashed down church doors, invaded privacy, and ignored rights).
- 2) Why has the Justice Department and FBI disregarded the 1st and 4th Amendment rights of the Church?

- 3) Why has the Justice Department together with FBI engaged in a 20 year campaign of harassment of the Church of Scientology?
- 4) Is this campaign an attempt to block reforms that expose Federal agency abuses?
- 5) Why is the Justice Department with FBI continuing punitive confinement of Rev. Arthur Maren? (now in jail over 7 months). Isn't the true reason because he is major Church of Scientology spokesman and has been the most vocal?


In closing it is our contention that harassment and intimidation from Justice Department has continued even after the notorious July 8th break-in.

Continued abuse of citizen rights can only serve to instill in the citizenry a greater distrust for Law Enforcement. For when society fails to give to Law Enforcement the respect needed for a properly directed society, then Law Enforcement will, in turn, fail to give to society protections it needs.

It's your responsibility as preservers of the citizen's welfare to make this happen.

We await your reply with patience befitting honest citizens interested in guaranteed restoration of their rights.

ADDENDUM CRIMINAL INVESTIGATIVE DIVISION (CID) 4/14/78 [REDACTED]

At approximately 11:00 a.m., 4/14/78, 30 to 40 demonstrators commenced picketing at the 10th and Pennsylvania entrance to the Department of Justice. These individuals also set up a cardboard replica of a church, which they proceeded to attack with a chainsaw and other unidentified implements, apparently depicting the FBI's search of the Church of Scientology. They departed at approximately 1:00 p.m., 4/14/78.

JUDGE MALCOLM M. LUCAS, FEDERAL COURT, LOS ANGELES, ADVISED APRIL 4, 1978 THAT THE QUESTION OF THE EXTENT OF DOCUMENT SEIZURE BY THE GOVERNMENT WILL BE RESOLVED ON MAY 15, 1978. SCIENTOLOGY LAWYERS ADVISED JUDGE LUCAS THAT THE COPY OF DOCUMENTS PROVIDED FREE OF CHARGE BY THE GOVERNMENT TO THEM IN AUGUST, 1977, HAS BEEN MICROFILMED AND THEN DESTROYED AS THEY WERE PREPARING FOR PREVIOUSLY HELD LEGAL MOTIONS. SCIENTOLOGY LAWYERS ARGUED THAT ANOTHER COPY OF THE SEIZED DOCUMENTS WAS REQUIRED IN ORDER TO PROPERLY PREPARE FOR THE NEXT COURT APPEARANCE. JUDGE LUCAS ORDERED THE GOVERNMENT TO PROVIDE THE SCIENTOLOGISTS WITH ANOTHER COPY OF THESE DOCUMENTS, 11 MAY 1 1978 HOWEVER, HE STATED THAT THE GOVERNMENT WAS TO BE REIMBURSED

FOR THE CO ST. ASSISTANT UNITED STATES ATTORNEYS (AUSA) IN WASHINGTON, D.C., AS WELL AS LOS ANGELES, HAVE REQUESTED THAT THE TRANSFER OF THIS ADD ITIONAL COPY BE ACCOMPLISHED AS SOON AS POSSIBLE SO AS TO FORESTALL POSSIBLE SCIENTOLOGY ARGUMENTS THAT THERE WAS NOT SUFFICIENT TIME FOR THE PREPARATION OF A DEFENSE FOR THE MAY 15 HEARING.

LOS ANGELES, IN JULY, 1977, REPRODUCED FIVE COPIES OF ALL DOCUMENTS SEIZED DURING SCIENTOLOGY RAIDS. THE EXPENDITURE FOR THIS REPRODUCTION WAS \$23,000, WHICH COVERED ONLY THE COST OF MATERIALS AND THE RENTAL OF MACHINERY. AGENT PERSONNEL WORKING THREE MEN TO A MACHINE, THREE - EIGHT HOUR SHIFTS FOR TEN WORK DAYS, ACTUALLY ACCOMPLISHED THE XEROXING. ONLY TWO COPIES OF THE FIVE COPIES REPRODUCED REMAIN INTACT. ONE OF THESE COPIES HAS BEEN DESIGNATED FOR THE OFFICE OF ORIGIN AND HAS BEEN PACKAGED FOR SHIPMENT AS SOON AS IT IS RELEASED BY THE COURT. THE OTHER COPY, IF TURNED OVER TO THE SCIENTOLOGISTS, WOULD LEAVE ONLY THE ORIGINAL DOCUMENTS AS A COMPLETE SET AVAILABLE TO LOS ANGELES. IT IS HIGHLY PROBABLE THE COPIES OF SPECIFIC DOCUMENTS, OR PERHAPS ENTIPE BLOCKS OF DOCUMENTS, WILL BE REQUIRED IN FUTURE COURT APPEARANCES, AND IF SUCH OCCURS, IT WILL REQUIRE ADDITIONAL XEROXING AND
