DETAILS: This case involves violations of numerous Federal criminal statutes by certain members of the COS, wherein several Government agencies have been penetrated by these individuals and numerous Government documents stolen. An intensive investigation has been conducted since the execution of search warrants by the FBI in Los Angeles, California, and Washington, D. C., on July 8, 1977. As a result of this investigation, the following officials of the COS have been indicted for conspiracy and Theft of Government Property:

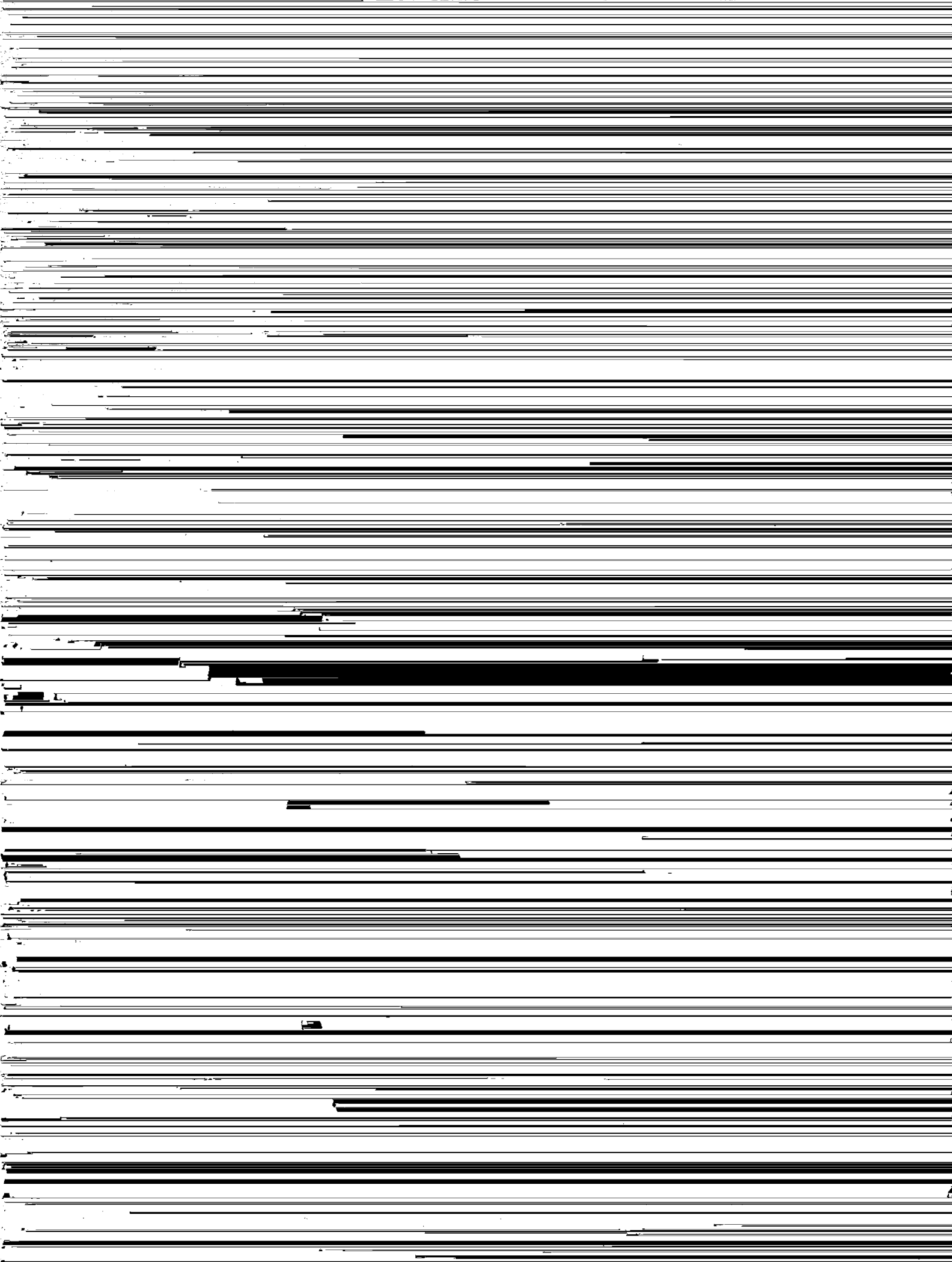
