On July 8, 1977, pursuant to the execution of a Federal Search Warrant on the Church of Scientology premises, known as Fifield Manor, located at 5930 Franklin Avenue, Hollywood, California, Special Agent [REDACTED] assisted in the maintenance of security in the lobby of these premises. The following pertinent activity was noted:

6:30 a.m.: Accompanied an individual who identified himself as [REDACTED] to room number 25 of area determined to be annex to Fifield Manor. Nothing pertinent noted.

6:32 a.m.: An individual who identified himself as [REDACTED] Advanced Organization of Los Angeles, extension [REDACTED] departed the lobby and proceeded to the area of the Business Office unescorted.

6:50 a.m.: An individual who identified himself as the [REDACTED] arrived in the lobby and indicated he was proceeding to the 6th floor of Fifield Manor.

9:06 a.m.: SA [REDACTED] made available press release information to a television crew from KTLA - TV, outside of Fifield Manor. At about 10:00 a.m., this press release information was made available to a television crew from KABC-TV on the 6th floor of Fifield Manor; and at about 12:36 p.m., the same information was made available to a television crew from KTTV-TV.
